# **KEYNOTE SPEAKERS**



Prof. Dr. Alwi Shihab, M.A.

Indonesian President's special envoy to the Middle East and the Organisation of Islamic Cooperation, Indonesia

**Prof. Dr. Alwi Shihab, M.A.** a figure who is widely known for his activities in various interfaith dialogue forums. Prof. Dr. Alwi Shihab, M.A. is not a new person in the field of Islamic studies. In almost every seminar on interreligious relations organized by universities and institutions in the United States, the holder of two

doctorates—from the University of 'Ain Syams, Egypt and Temple University, United States was asked to be one of the speakers. Not many people know, before being known in his figure as it is now, Prof. Dr. Alwi Shihab, M.A.was once known as a businessman around the 1970s. Departing from his father's will which turned out to actually fall to Prof. Dr. Alwi Shihab, M.A. who was busy doing business at that time. made Prof. Dr. Alwi Shihab, M.A.promise to pursue more in the field of preaching and education. The will held by Prof. Dr. Alwi Shihab, M.A. began with a prayer book that was a hereditary inheritance from his grandmother. Alwi slowly began to reduce his busyness in the business world and took his bachelor's degree in the field of philosophy IAIN Ujung Pandang in 1986. At that time Prof. Dr. Alwi Shihab, M.A. had actually held a master's degree from Al-Azhar University, Egypt, in the same field. In 1990, Prof. Dr. Alwi Shihab, M.A. received his first doctorate from the University of Ain Shams, Egypt, in philosophy. Because he did not feel enough, he then moved to America to continue his studies in the field of religion. Temple University was his choice. It was there that he later earned his second doctorate, in 1995. Prof. Dr. Alwi Shihab, M.A. then attended the postdoctoral program at the Center for the Study of World Religion, Harvard University, Boston for one year, then became a lecturer in Islam at the Hartford Semi-Nary, now known as the Hartford International University for Religion and Peace, Connecticut. In the government area, Prof. Dr. Alwi Shihab, M.A. served as foreign minister during the presidency of Gus Dur, the coordinating minister of public welfare during the administration of Susilo Bambang Yudoyono, and as the special envoy for presidential affairs for Middle East affairs during the administration of President Joko Widodo.

He was awarded the Award of the Republic of Portugal's Grã-Cruz da ordem do Mérito, the highest medal of Portugal's Honorary Orders of Civil Merit.



# Development Of Augmented Reality Based Learning Media On Technology, Information and Communication (ICT) Learning Outcomes

#### **Abstract**

Augmented Reality technology as a learning medium can encourage people to think realistically, without having to bring in the practical tools directly. This research aims to determine the process of developing learning media based on augmented reality applications in TIK subjects to improve student learning outcomes at SMPN 56 Bekasi City and to determine the feasibility of learning media based on augmented reality applications in TIK subjects to improve student learning outcomes at SMPN 56 Bekasi City. The targets of this research were students in class VII at SMPN 56 Bekasi City. This research approach uses research & development research. The data analysis techniques used in this research are, 1). Material expert evaluation data analysis techniques, 2). Media expert data analysis techniques, 3). Student evaluation data analysis techniques, and 4). Field test data analysis techniques. The product was tested on a media expert, a material expert, a learning design expert, 2 students in a one-to-one trial, 10 students in a small group trial, and 30 students in a field test. Assessment uses a 1-3 rating scale. The results of this research show that the average formative evaluation of media experts is 83.33%, material experts are 86.67%, learning design experts are 81.67%, so the development of Augmented Reality (AR) learning media is categorized as very feasible. The average one on one assessment score for all aspects was 78.70%. The average achievement of small group assessments in all aspects was 88.25%. The increase in students' knowledge capacity by 20% after using Augmented Reality (AR) learning media can be seen from the students' overall learning results during the pre-test which had an average score of 57.67 to 77.67 after the post-test.

#### **Abstract**

The toughest challenge for education policy makers is to provide programmers' that can help mountain tribe children to be immersed into the English learning process, so that they can overcome their learning difficulties. This research highlights this by providing an English camp for mountain tribe children at the foot of Binaiya mountain, Central Maluku, Indonesia. This study used a quasi-experiment with a one-group pretest-posttest design. The independent variable (English camp) in this study was designed according to the context of the lives of mountain tribe children who live under the foot of Mount Binaiya, Central Maluku, Indonesia. The results of this study prove that English camp can predict the interest of mountain tribe children in Binaiya in learning English. This prediction can occur because English camp provides learning strategies that can create immersion subjects so as to facilitate children's self-determination and learning comfort. The limitations of this study are that it did not fully control for threat factors and present a comparison group. Therefore, we recommend future researchers to control for these threatening factors by considering the involvement of tutor background as well as presenting a comparison group in future research.



The idea of a "Clash of Civilizations" between Islam and the West has gained traction since the events of September 11, 2001. This has created a divide between two extreme viewpoints of the world which lead to truth claims and terrorist action. Countries like Indonesia and Turkey as large populations and developing economies country struggle with Western views that often mistakenly link Islam solely to Arab culture, neglecting the diverse interpretations in these regions. Many studies recently focused on moderate Islamic education, since the studies on the moderation of Islamic Education across different cultures are still limited. This research aims to compare the values of moderation in the Islamic education curricula of IHS Fatih Sultan Mehmet Istanbul (Turkey) and MAN Insan Cendekia Serpong (Indonesia), examining how local culture influences these values. Qualitative methods were used in variants of literature studies, collecting data from documents, books, and articles. Using comparative component analysis and data validation through source triangulation, The findings reveal that both educational systems emphasize moderation and tolerance, but their cultural contexts differ. Local culture significantly shapes Islamic education; Indonesia incorporates local wisdom and diversity, whereas historical traditions and national identity influence Turkey's approach. Ultimately, the result of the study shows that Islamic education in Indonesia and Turkey is classified as moderate education with different parameters. This study investigates the development of figh al-bi'ah (environmental figh) and the role of da'wah in addressing the urgent global ecological crisis. By integrating fiqh and da'wah approaches, it explores how ulama (Muslim scholars) use Qur'anic and Hadith evidence to create legal guidelines that promote environmental conservation. The research underscores the significance of da'wah in enhancing ecological awareness within the Muslim community, utilizing principles like tahqiq al-maslahah (achieving benefit) and saddu al-dhara'i (preventing harm) as Sharia foundations. #### **Abstract**

This study investigates the relationship between university students' understanding, perception, and expectations of Islamic economics in reducing social inequality in Jakarta. The research adopts a quantitative methodology, with data collected from 522 students in the Jabodetabek region through a Likert scale-based survey. The study found that students who possess a thorough understanding of Islamic economic principles are more likely to have a positive perception of the system's ability to address social inequalities. Students' expectations of Islamic economics' role in reducing social disparities were shaped by their perceptions of its fairness and effectiveness. The findings highlight that while students are optimistic about the potential of Islamic economics to reduce inequality, they also acknowledge several barriers to its implementation, including a lack of public understanding and limited financial literacy. This study underscores the critical role of education in shaping students' perceptions and expectations of Islamic economic systems. The research concludes by recommending that educational institutions adopt more comprehensive curricula that integrate practical applications of Islamic finance, enabling students to better understand its potential in real-world contexts. Moreover, the study advocates for greater collaboration between the government and Islamic financial institutions to develop policies that address social inequalities through Islamic economic mechanisms. The findings provide valuable insights for policymakers and educators aiming to optimize the role of Islamic economics in creating a more equitable society in Jakarta.

## Reorganization of the Directorate General of Taxes to the Indonesian Tax Authority Body: Is It Urgent?



#### **Abstract**

The performance of the Directorate General of Taxation in supporting state finances is very dominant, where each year, the contribution of taxation income supported eighty percent of the total APBN, but the tax ratio level each year is less than eleven percent. The performance of the Directorate General of Taxation is not supported in terms of balanced rewards so efforts are needed to reorganize tax institutions at the ministerial level. The method used is normative juridical with a statutory regulatory approach and prescriptive analysis. Primary and secondary legal sources are collected from literature studies to support the analysis of problems related to reorganization, taxation, and legal reform related to taxation. The aim is to examine and analyze the optimization of state revenues by changing the tax institutions into autonomous institutions at the ministerial level. The results of the analysis show that in the future the Directorate General of Taxation needs to be upgraded to a semi-autonomous Agency or Authority through the establishment of a Tax Autonomy Body, because before there is a change in the Law on State Ministries (UUKN) and the State Finance Law by the regulator, full tax autonomy (at the ministerial level) will not be realized.

#### Is Dading Deed in Mediation in Court Effective?

#### **Abstract**

Mediation is a dispute resolution regulated in PERMA No. 1 of 2016, providing hope for the parties to restore their image and social relations through deliberation and consensus. The product of mediation is a dading deed, an agreement made by the parties, and is recognized and has legal certainty. This study aims to analyse the effectiveness of a dading deed as a dispute resolution tool in court. This study uses a normative legal approach by reviewing applicable laws and regulations and analysing related cases resolved through mediation with a dading deed. The study results indicate that a dading deed has the same binding force as a court decision, thus providing legal certainty for the parties. However, implementing the dading deed faces obstacles, such as delays in implementation and non-compliance by one of the parties. Therefore, efforts are needed to improve the effectiveness of the dading deed through strengthening regulations and monitoring mechanisms. This study concludes that the dading deed has effectiveness in dispute resolution but needs improvement in its implementation.

This research aims to determine: 1) the relationship between Technology Literacy and Digital Mastery Performance; 2) the relationship between Work Creativity and Digital Mastery Performance; and 3) the combined relationship of Technology Literacy and Work Creativity with Digital Mastery Performance. This study uses a quantitative research type, employing survey methods and correlational techniques. The target population is the employees of PT. Sentosa Raya Bumi Agung Jakarta, totaling 390 employees. The sample in this study consists of 130 employees of PT. Sentosa Raya Bumi Agung Jakarta. The sample was selected using the Slovin formula with a 5% margin of error, resulting in 98 employee respondents at PT. Sentosa Raya Bumi Agung Jakarta. The research results show that: 1) The Technology Literacy variable has a positive relationship with Digital Mastery Performance, as indicated by the accepted hypothesis, which is proven by data analysis results showing t calculated (7.78) > t table (1.66), thus accepting the hypothesis that Technology Literacy positively affects Digital Mastery Performance. 2) Work Creativity has a positive relationship with Digital Mastery Performance, as indicated by the accepted hypothesis, which is proven by data analysis results showing t calculated (9.46) > t table (1.66), thus accepting the hypothesis that Work Creativity positively affects Digital Mastery Performance. 3) There is a relationship between Technology Literacy and Work Creativity with Digital Mastery Performance. The combined relationship of Technology Literacy and Work Creativity with Digital Mastery Performance is 58.7%.

## Sustainability of Product Halal in the Postmarket Phase from the Perspective of Islamic Law in Indonesia

#### **Abstract**

This research aims to analyze the assurance of halal products in Indonesia, particularly within the context of Islamic law in the post market phase. The study focuses on understanding how existing regulations are capable of providing legal protection for Muslim consumers and ensuring the halal status of products throughout the entire distribution process, from production to consumption. The method used is normative research with a legislative approach, a conceptual approach, and a historical approach. This research examines various regulations related to halal product assurance, including the Halal Product Assurance Law and other related regulations, and analyzes the consistency and implementation of these regulations within the context of Islamic law. The findings of the research indicate that although Indonesia has strong enough regulations to ensure the halal status of products, implementation in the post market phase still faces significant challenges. The monitoring of products already circulating in the market has not been fully effective, and there are gaps in the synchronization of existing regulations. From the perspective of Islamic law, halal assurance must cover the entire product life cycle, and therefore, more proactive monitoring and better synergy among related institutions are needed to ensure the sustainability of halal products in Indonesia.


